EXECUTIVE DIRECTOR'S REPORT

W. Cook informed the Board that the Economic Interest Statements can now be completed on line. He was also pleased to inform the Board that the Liability Insurance renewal increase for 2011-12 was small and the Park District received a 10% discount due to an excellent record in 2010.

The Mt. Prospect Baseball Association will be celebrating its 60th anniversary this year. A parade and celebration is being scheduled for Saturday, April 16, 2011 and the Board's participation is welcome. More information will be forthcoming.

Commissioner Caporusso asked W. Cook if there were any plans being considered in regard to repairing the roof at RecPlex. W. Cook explained that because this is a very large building, it is

estimated that the cost of repairing the entire roof at one time would be over \$1,000,000. Staff is therefore investigating the possibility of completing the project in phases. He will report back to the Board when he has more information.

MEADOWS POOL FLOOR RESURFACING

The repair work at Meadows Pool will start on Tuesday, April 5 with completion anticipated in ample time for the scheduled opening. Due to this tight timetable and the fact that the funds for the project come from all parties involved and therefore held in an escrow account, the project is considered an emergency and is being scheduled without the competitive sealed bid process.

President Eilering asked for a motion in order for discussion to continue.

Commissioner Doherty move to award the Meadows Pool floor repair contract, to be paid from funds received from various defendants in the now settled lawsuit, to be awarded to SBI (Schaefges Bros, Inc.) in the amount of \$6,000, without competitive sealed bids, as same is being paid for with other people's monies and is being done on an emergency basis so that the pool can be opened in a timely fashion for the summer; seconded by Commissioner Klicka.

AUTHORIZATION TO SERVE LIQUOR AT SPECIAL EVENTS

W. Cook reminded the Board that in order to comply with the requirements of the State Liquor License and the Park District Code, the Board is required to authorize the serving of alcoholic beverages at special events. The organizations sponsoring these events must meet the specified requirements that are to be included in the motion.

Commissioner Doherty moved to authorize serving alcoholic beverages for the named events providing the organizations sponsoring the events meet the following requirements:

- 1. If an admission fee is charged, guests must receive something in return other than alcohol.
- 2. There is no charge for the alcohol.
- 3. Dram Insurance Liability in maximum insurance coverage limits must be provided with Mt. Prospect Park District named additional insured.

4. The organization agrees to obey the rules and regulations provided by the Mt. Prospect Park District, the State of Illinois and the ordinances of the Village of Mount Prospect or City of Des Plaines. Failure to do so may result in the immediate termination of the privilege to serve alcohol at the event in the discretion of the park district.
